#### Note to the reader

The latest available consolidated trade data at EU level cover market developments up to February 2025. Monthly figures are compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.

The trade figures are expressed in values, except when specifically mentioned. Price variations are based on a unit value that is the average price of products traded in the period concerned (trade value at the border divided by the quantity registered).

# HIGHLIGHTS: EU agri-food trade surplus rebounded in February 2025, with lower import values

EU exports reached EUR 19.6 billion in February 2025, an increase of 3 % on the previous month and 1.4 % higher than in February 2024. The value of exports of cocoa products and coffee increased due to rising prices, while it decreased for cereals.

EU imports decreased by 5 % month-on-month in February, reaching EUR 15.2 billion. This remained 15 % higher than in February 2024. This is explained by high import prices, in particular for cocoa and coffee, as well as fruit and nuts.

The EU agri-food trade surplus reached EUR 4.4 billion in February 2025. This is a 47 % increase compared to the previous month, explained by the reduced imports in February. However, this remains 28 % lower than in February 2024, primarily due to the increase in prices of EU imports, in particular for cocoa products, coffee, and fruit and nuts.





## **EU AGRI-FOOD EXPORTS**

#### EU EXPORTS INCREASED IN FEBRUARY

**EU agri-food exports reached EUR 19.6 billion in February 2025**, a 3 % increase on the previous month and 1.4 % higher than in February 2024. In the first two months of the year, EU exports were EUR 984 million higher than in 2024 (+3 %).

The **UK** remained the first destination of EU exports, with an increase of EUR 322 million (+4%) in January-February 2025 compared to the same months in 2024. This was explained by increases across a variety of products, including cocoa and coffee products, and protein crops.

The **US** remained the second destination of EU exports, with an increase of EUR 413 million (+9%) in the first two months of the year compared to 2024. This is partly explained by an increase in the value of cocoa products exports and wine products.

**Switzerland** was the third destination of EU exports between January and February. Exports grew by EUR 243 million (+12 %) compared to 2024, due to increases in the value of cocoa products and other products.

On the other hand, EU exports to **China** had the largest reduction, with a decrease of EUR 330 million (-15 %) compared to 2024. This is mainly explained a strong reduction in volumes of cereals exports (-1.5 million t, -99 %).

Other reductions in EU exports in January-February were observed in direction of **Saudi Arabia** (-EUR 91 million, -11 %), due to lower exports of tobacco, sheep and goat, and preparations of fruit, nuts and vegetables. Exports also decreased to

**Japan** (- EUR 78 million, -6 %) and **Singapore** (- EUR 62 million, -19 %, mainly due to reduced spirits and non-edible products exports) and **Pakistan** (- EUR 54 million, -51 %, mainly in cereals).

## PRICES OF COCOA PRODUCTS AND CONFECTIONERY SUSTAIN EU EXPORTS


Exports in the **coffee, tea, cocoa and spices** category had the largest increase in value, by EUR 758 million (+52 %) in January-February 2025 compared to 2024. This was mainly driven by a strong price increase for cocoa paste, butter and powder, as well as coffee.

Exports of **confectionery and chocolate** also increased by EUR 329 million (+19 %), mainly due to increases in prices. Exports of **dairy products** increased by EUR 158 million (+5 %), primarily due to increases in prices.

On the other hand, EU **cereals** exports decreased by EUR 767 million (-30 %) in the first two months of 2025 compared to 2024. This is mainly explained by reductions in exported volumes, both for wheat and maize.

Exports of **preparations of fruit, nuts and vegetables** decreased by EUR 139 million (-6 %), due to reduced volumes.

Exports of **olives and olive oil** decreased by EUR 133 million (-11 %), as prices have eased up after their peak in 2024, while volumes exported increased by 9 %.



## **EU AGRI-FOOD IMPORTS**

## EU IMPORTS DECREASED, BUT REMAINED HIGH IN FEBRUARY

The value of EU agri-food imports reached EUR 15.2 billion in February 2025. This is 5 % lower than the previous month, but remains 15 % higher than in February 2024. Over the first two months of the year, they had increased by EUR 4.6 billion (+17 %) year-on-year. This is explained primarily by high prices for a number of EU imports, in particular for cocoa products and coffee.

Imports originating from **Côte d'Ivoire** had the largest increase in value in January-February 2025 compared to 2024 (+ EUR 733 million, +73 %), mainly due to high cocoa prices.

Imports from **China** increased by EUR 447 million (+32 %), due to increases across most products categories, notably non-edible products (fatty acids and waxes, and plant fibres).

Imports from **Canada** increased by EUR 344 million (+80 %), mainly due to higher oilseeds and cereals imports.

Imports from **Australia** increased by EUR 330 million (+149 %), mainly due to an increase in rapeseed imports.

Imports from the **US** increased by EUR 329 million (+14%), in particular due to an increase in imports of maize (partially replacing maize from Ukraine).

On the other hand, imports from **Ukraine** decreased by EUR 237 million (-10 %), mainly due

to lower imports of cereals (maize and wheat) and oilseeds (rapeseed).

Imports from **Russia** decreased by 77 % (-EUR 207 million) in January-February 2025 compared to 2024, largely due to a sharp reduction in imports of oilseeds and cereals.

## COCOA, COFFEE, FRUIT AND NUTS DRIVE EU IMPORTS


Imports of **coffee, tea, cocoa and spices** increased by EUR 2.5 billion (+59%) in the first two months of 2025 compared to 2024. This is explained by the continuous high prices of cocoa and coffee.

Imports of **fruit and nuts** also grew by EUR 772 million (+20 %), mainly due to increased prices (+16 %) and higher imported volumes of grapes, nuts and bananas.

Imports of **non-edible products** also increased by EUR 283 million (+20 %), due to both higher prices and volumes.

On the other hand, imports of **oilseeds and protein crops** declined by EUR 245 million (-7 %), mainly due to lower prices while volumes remained overall stable.

Imports of **sugar and isoglucose** decreased by EUR 162 million (-46 %). This is mainly explained by reduced imported volumes. Imports of **olives and olive oil** decreased by EUR 99 million (-31 %) due to both lower import prices and volumes.
